Our family consists of four adult children all of whom are working in trades or studying at Lincoln University. We have 2 full time staff as well as periodically employing agriculture students and using local contractors for the manual labour side of sheep farming.



I have been farming for 36 years under my own identity and have extended years of governance experience within our business and community. I am the managing director of Smith Farming 2018 Ltd and Trustee of JJ Smith Family Trust. I previously chaired the Te Tipua School board and been an active member of Pioneer Rugby committee along with Southland Boys High School Rugby as chairman & committee member. Currently I am the Pioneer senior rugby coach (5yrs) within this role it has taught me some valuable life skills and how to create a successful team environment ensuring we achieve the common goal. Rugby has enabled me to meet a large network of people who farm or are reliant on farming for a living. With this and constant communication with agents and farmers whilst purchasing stock I feel I have a broad sentiment of how shareholders and farmers are feeling.
