#### ASSESSMENT OF ADRIAN BALL

Adrian joined the Silver Fern Farms Co-operative Board in 2022 as a Board Appointed Farmer Director. He notes his ongoing commitment to the organisation and motivation to 'give back to the agri sector'

Adrian is the Managing Director of Dennley Farms, a 196 ha fully integrated dairy and beef finishing farm, and Chair of Rahinga Dairies in Southland. He is a previous Waikato Regional Supreme Winner of the Ballance Farm Environment Awards and was also awarded the Gordon Stephenson Trophy, becoming a National Ambassador for Sustainable Farming and Growing.

Since his appointment to the SFF Co-operative Board, Adrian has been directly involved in setting organisational strategy and engaging with the senior management team. He has strengthened his strategic skills across international market development, supply chains and production, and sales and marketing with direct insights to SFF's business operations. He is also a member of the Remuneration and Appointments Committee.

Adrian has significant experience in sustainability and environmental farm system development. He was a farmer representative in Fonterra's strategy review helping develop the 'Co-operative Core Values, Vision and Purpose' workstream and the 'Co-operative Difference' farm assurance reward scheme.

In 2023 he was appointed to the Fonterra Sustainability Advisory Panel, a group providing guidance to Fonterra's board and management on the organisation's ESG strategy. He has also completed market tours, trade delegations and study trips to South America, China and Europe.

Adrian has demonstrated strong governance potential and strategic focus since his appointment to the SFF Co-operative Board. If elected, he will continue developing insight into the operating company and international commercial partnerships. The transition from 'Board Appointed' to 'Farmer Elected' Director is not expected to impact his role.

She prides herself on producing high quality, nutrient dense protein while caring for people and the planet. This is showcased with her early FAP Plus gold certification.

Her involvement in both strategic and operational aspects of the business showcase her commercial capability merged with a deep understanding of grass roots farming. This is further highlighted by her recognition as the Institute of Directors, Otago/Southland branch's Emerging Director of the Year in 2023. Jo's current roles, including Director for North Otago Irrigation Company Ltd, Trustee for Meat the Need, and a Steering Committee member of North Otago Sustainable Land Management, demonstrate her pragmatic and results-driven approach.

#### **ASSESSMENT OF JO HAY**

Jo notes her passion for the red meat industry and co-operative model. Drawing from her community-focused and representative roles, Jo is interested in the Silver Fern Farms directorship to continue developing her governance skills in the primary sector.

Jo is a partner in a 270 ha sheep and beef farming operation.

Jo is a director of the North Otago Irrigation Company (NOIC) and is a member of the Remuneration Committee. The company is owned by farmer shareholders and has an asset base of \$150m+. Since joining NOIC in 2022, Jo has developed her commercial strategy and financial insight through a scheme share process and gained exposure to broad stakeholder groups including iwi and regulators.

Jo has been a trustee of Meat the Need since 2023, a charity that supplies farmer-donated food to community organisations and food banks across the country. In this role, she is growing her awareness of larger commercial supply chains and stakeholder partners.

Jo's farming operation is NZFAP Plus certified and was the first in Otago to achieve the gold standard accreditation. She is also on the Steering Committee of North Otago Sustainable Land Management, a community-oriented organisation focused on promoting sustainability practices, land management and community development.

Silver Fern Farms is of significantly larger scale than Jo's other roles. If elected, she would focus on developing her governance skillset across areas including scale market development and financials, and commercial production to apply to SFF Cooperative's operational complexity.



Jo has a logical approach to decision-making, considering both the short- and long- term consequences. She is expected to enjoy preparing for meetings and be relationship-focused. At times, Jo may need to take a more active role in shaping discussions.

Jo has a Bachelor of Education (Teaching) from the Dunedin College of Education. She is an Agri-Women's Development Trust Escalator Graduate. She is also a member of the Institute of Directors and was awarded the IoD Otago Southland Branch Emerging Director Award in 2023.

#### **ASSESSMENT OF JASON SMITH**

Jason is a career farmer and has held representative roles in his community. He is interested in the Silver Fern Farms role to learn about the inner runnings of the business and notes his desire to contribute for all shareholders to prosper.

Jason is the Managing Director of Smith Farming 2018, a 917 ha farming operation with 2 full time staff, finishing 60,000 beef and lamb stock units this season.

Jason's prior community-focused roles include coaching Southland age group representative and senior club rugby, along with membership of the Pioneer RFC committee and Chairing the Southland Boys High School Rugby. He was a trustee and Chair of the Te Tipua School Board as well as being on the Te Tipua Transport Society board.

Smith Farming 2018 is NZFAP Plus certified and has achieved the gold standard accreditation.

If elected, this would be Jason's first large commercial governance role. A range of skills will take time to develop given Silver Fern Farms' scale and complexity including supply chain management, operational financials and stakeholder engagement beyond the farm gate, and organisational turnaround.

Jason has a logical and intuitive style and can balance focus between the short- and long-term consequences of decisions. He is expected to be a confident contributor with a frank and pragmatic approach to discussions.

#### ASSESSMENT OF GABRIELLE THOMPSON

Gabrielle is a current elected director of SFF Cooperative. She was the inaugural Board Appointed Farmer Director and has focused her governance roles in the rural and agribusiness space. She notes her passion for SFF and the sector as motivation to stand for re-election.

Gabrielle is a partner and owner operator of a 530 ha arable and store lamb farm. In her earlier career she also practiced as a veterinarian.

Gabrielle draws from 5 years of experience as a director on the SFF Co-operative Board.

Through her tenure, she has been directly involved in setting strategy, working with the senior management team and building knowledge of the business' operational complexities. She has

demonstrated experience and exposure to CapEx projects, organisational growth, international trade and supply chains, and engagement with broad stakeholder groups (including regulators and unions).

She has managed a number of entrepreneurial and commercial ventures. In 2004 she opened a veterinary clinic and grew the practice to 5 clinics with \$5m turnover and 40 staff before successfully selling the operation to a national vet company. Through these businesses, she developed her SME, people management, retail, FMCG and H&S skill sets.

Gabrielle's wider governance experience includes membership on the Lincoln University Council. She is Chair of the Farms Committee which oversees the university's large farming enterprises and asset base. For 9 years, she was also an elected director of Ashburton Trading Society / Rural Co, a farming retail co-operative with \$250m turnover.

Gabrielle's farming operation is NZFAP Plus certified and has achieved the gold standard accreditation. It is also A-rated in audits for water systems.



Gabrielle is expected to continue applying her strategic and operational knowledge of SFF Cooperative to decision-making. If re-elected, she may focus on building greater insight into the operating company and Chinese markets.
